Retail Commodity Survey, May 2019

Released at 8:30 a.m. Eastern time in The Daily, Friday, August 9, 2019

Monthly data from the Retail Commodity Survey are now available for May. The survey collects detailed information about retail commodity sales in Canada to produce estimates of the distribution of sales of various commodities at the national level.

Retail sales totalled \$57.9 billion in May, up 13.5% from the previous month. Sales were up in 16 of the 19 commodity groupings.
