

# Urban public transit, July 2021

Released at 8:30 a.m. Eastern time in *The Daily*, Wednesday, September 22, 2021

## Highlights

Public transit ridership increased in July, as COVID-19 restrictions eased in many provinces and vaccination rates continue to climb. However, recovery toward pre-pandemic levels remains slow with ridership currently sitting at 40.5% of the number from the same month in 2019.

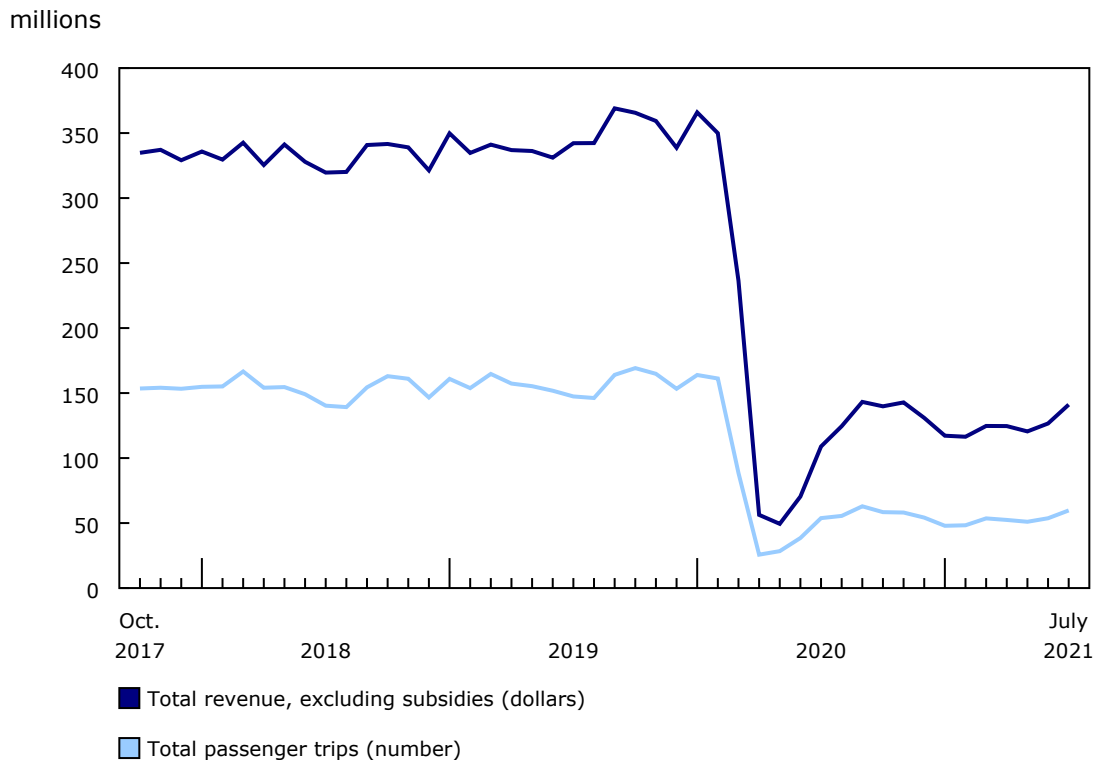
## Ridership still trails pre-pandemic levels

In July, an estimated 59.7 million passenger trips were made on Canada's urban transit networks, an increase of 11.0%, or 5.9 million trips, from July 2020. This marked the fourth straight month with a year-over-year increase and the highest number of passengers in 10 months.

More passengers used public transit in July as restrictions related to the COVID-19 pandemic were eased in many provinces. Despite this growth, ridership remained well below July 2019, at 87.7 million fewer passengers.

On a monthly basis, ridership typically declines from June to July with more vacations and fewer students. In July 2021, however, ridership rose by nearly 6.0 million from June, a 11.2% increase. With the easing of COVID-19-related restrictions in Quebec and Ontario, these two provinces accounted for 4.8 million (80.0%) of this growth.

## The financial situation remains fragile

With ridership well below pre-pandemic levels, the financial situation remains fragile for transit agencies. Total operating revenues (excluding subsidies) reached \$141.1 million in July, up 29.6% from July 2020. Despite the growth, this represents just over 41 cents for every dollar of operating revenue earned in July 2019.

### Note to readers

*Data for the most recent quarter are subject to revision. The data in this release are not seasonally adjusted.*

*This survey collects data on operating revenue (excluding subsidies) and the number of passenger trips from a panel of urban transit companies that represents at least 75% of revenues in each province and territory. Users should note that the panel is adjusted annually to maintain the 75% coverage and could differ slightly from what it was in the same month a year earlier.*
