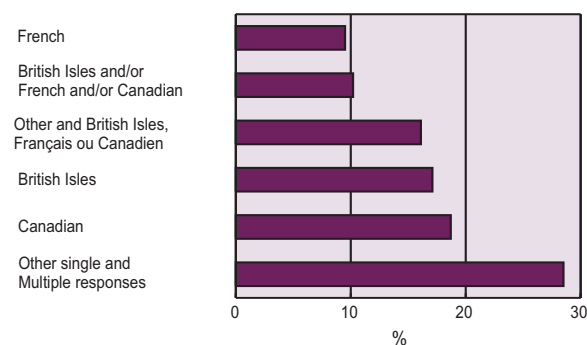

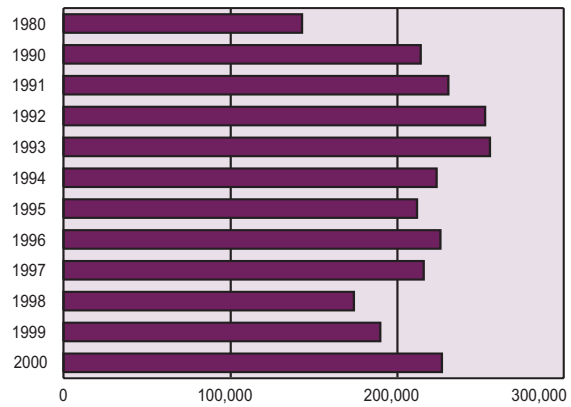
Family size (census)

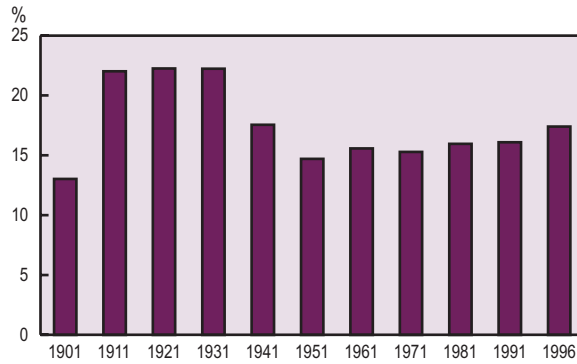

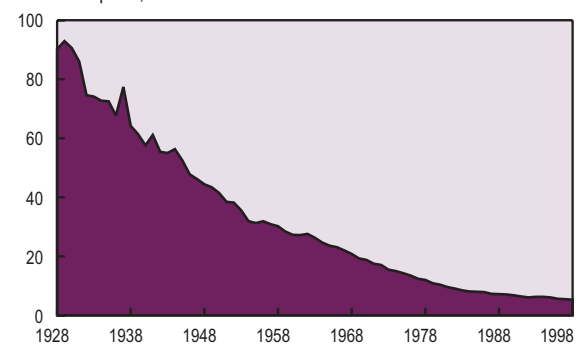

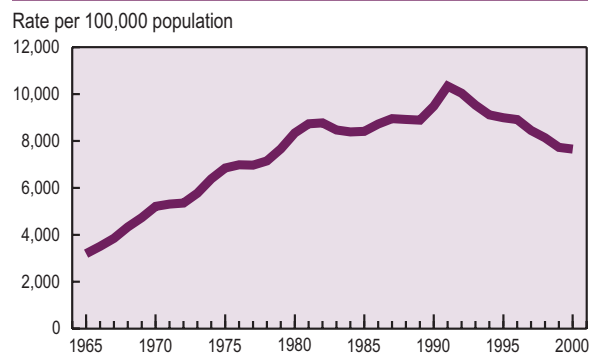

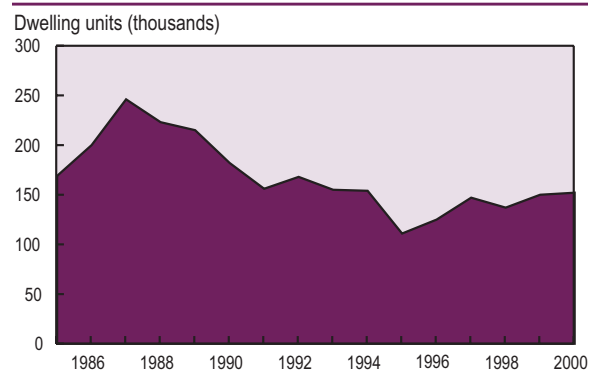

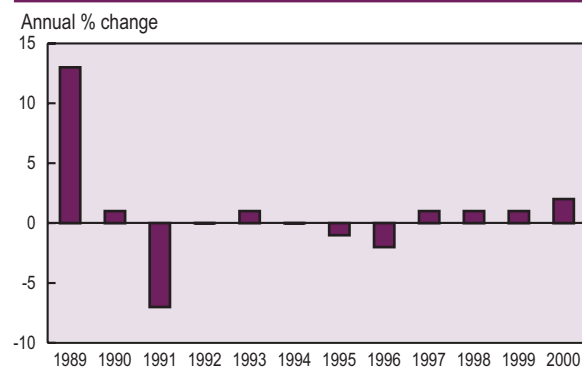

Canada's New Housing Price Index



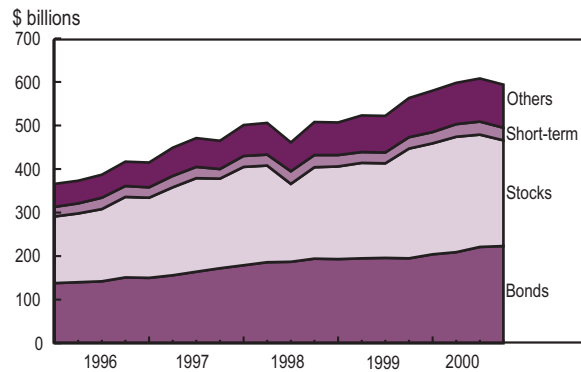

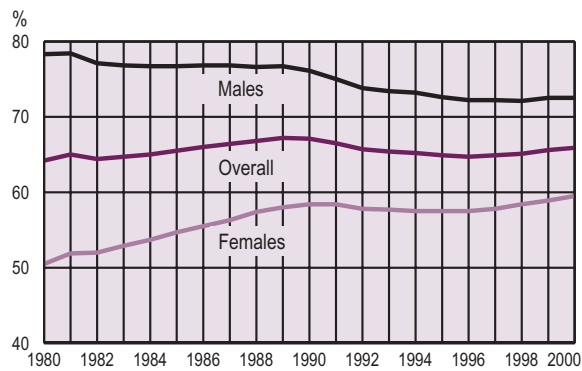

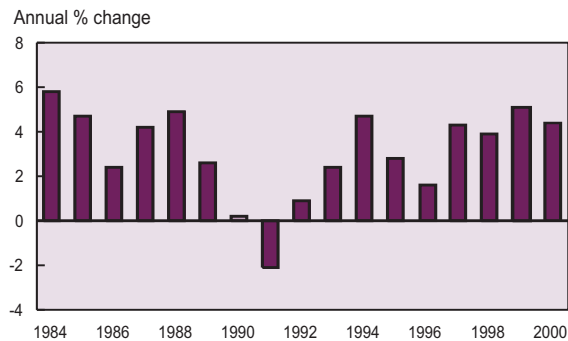

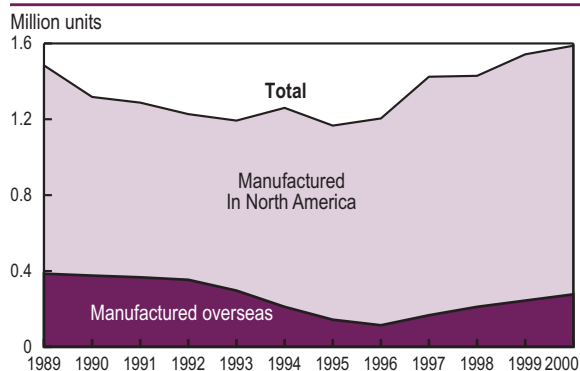

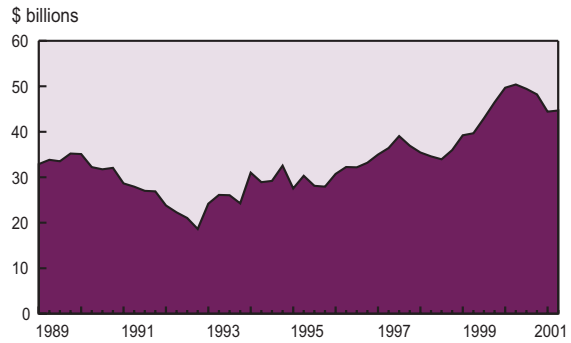

Quarterly operating profits of Canadian enterprises¹

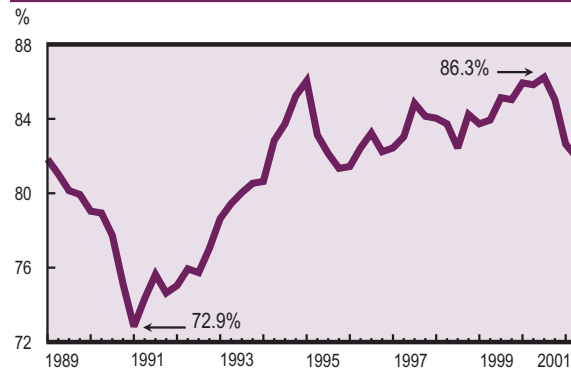

Capacity utilization rates in manufacturing industries

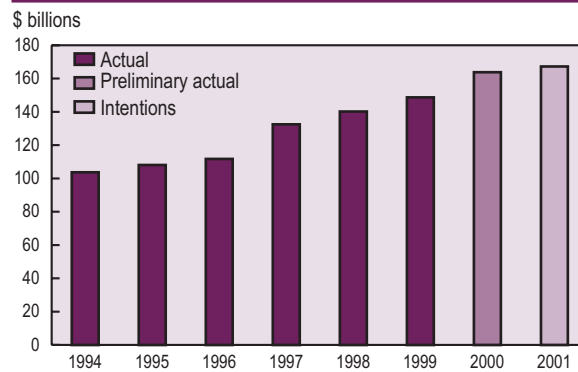

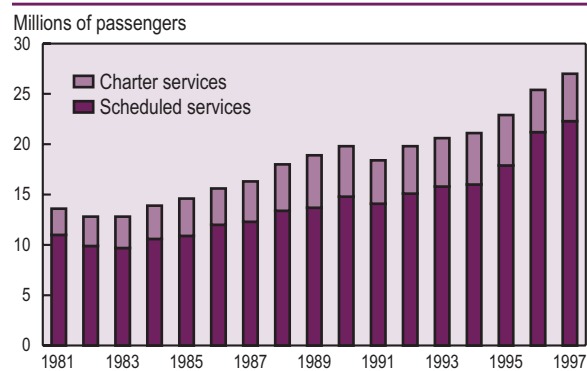

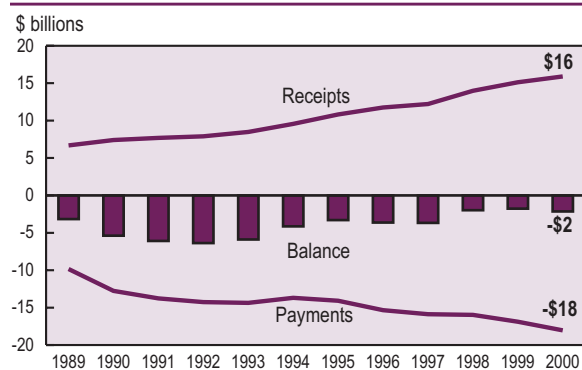

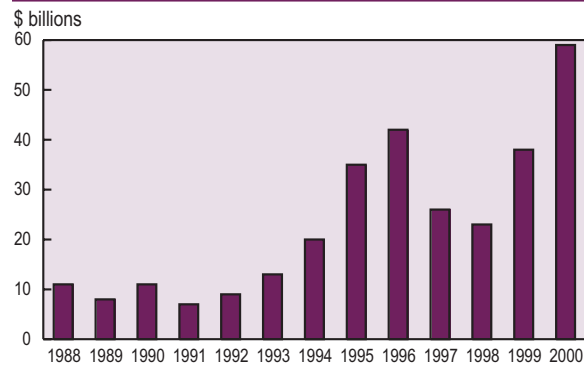

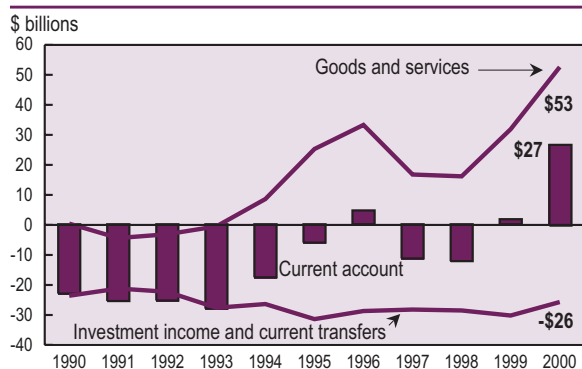

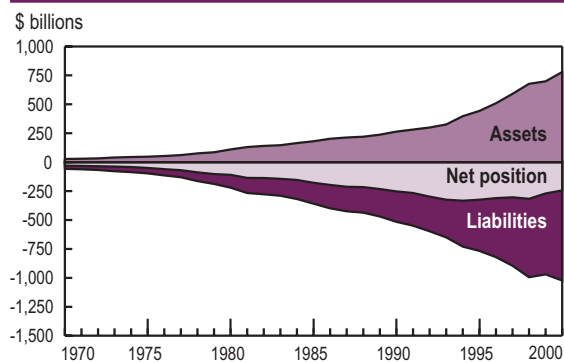
