### CABLE AND OTHER PROGRAM DISTRIBUTION, 1999

Cable operators reported revenues of \$3.3 billion in 1999, a 10.0% increase over 1998. This relatively strong growth is due in large part to a 26.0% increase in revenues from the provision of discretionary programming services and non-programming services. During the same period, revenues for wireless operators reached \$171.1 million, almost 4 times more than in the previous year.

Cable operators had 8.0 million subscribers at the end of August 1999, a small increase of 0.6% over 1998. Competition from wireless operators was felt most by small cable operators. More than 40.0% of cable systems reported a decrease in number of subscribers, the vast majority of them small systems with less than 10 thousand households in their licencing area. During that period, the number of subscribers to wireless services reached 554 thousand, compared to 233 thousand a year earlier.

The entry of wireless service providers and the growth of new services had a significant impact on the industry's employment level which reached 12,286 in 1999, compared to 9,472 in 1998.

### TÉLÉDISTRIBUTION, 1999

Les câblodistributeurs ont enregistré des recettes 3,3 milliards de \$ en 1999, une augmentation de 10,0% par rapport à 1998. Cette hausse relativement rapide s'explique en grande partie par la croissance de 26,0% des recettes provenant de la prestation de services de programmation facultatifs et de services hors programmation. Pendant cette période, les recettes des opérateurs sans fil ont été de 171,1 millions de \$, presque 4 fois plus qu'en 1998.

Les câblodistributeurs avaient 8,0 millions d'abonnés à la fin du mois d'août 1999, soit 0,6% de plus qu'en 1998. Les petits câblodistributeurs ont été plus touché par la compétition provenant des opérateurs sans fil. Plus de 40% des câblodistributeurs ont déclaré une baisse du nombre d'abonnements, et la plupart de ceux-ci étaient de petits opérateurs avec moins de 10,000 ménages dans la zone desservie. Pendant cette période, les abonnements auprès des fournisseurs de services sans fil ont atteint 554,000 comparativement à 233,000 l'année précédente.

L'arrivée d'opérateurs sans fil et la croissance des nouveaux services ont eu un impact important sur le niveau de l'emploi dans l'industrie qui a atteint 12,286 en 1999 comparativement à 9,472 en 1998.
